


- About Cybersecurity ----


Cyberattacks continue to increase in both quantity and sophistication, while organizational systems are becoming increasingly complex. Security services are under strain, as always. Today's Security Operations Center (SOC) has many areas of responsibility and not enoughstaff to handlei tall.

64% of SOC teams complain about the complexity of interacting with different security tools and management consoles that are poorly (or not at all) integrated, making thorough and timely incident investigation and response difficult.

49% say they lack the personnel for manual analysis, investigation, and response to the growing volume of security events.

No one can guarantee security even up to 50% due to the inevitable human factor.

The strongest password encryption can be compromised not by a virtual hacker, but by an ordinary employee who falls victim to a phishing site or inserts an unchecked USB drive into a work computer.

There is no foolproof defense against the human factor; the main focus should be on minimizing consequences and damages through swift incident response.

To address these challenges, it is necessary to employ methods of private internet intelligence - OSINT.

- What is OSINT? ---

Open Source Intelligence, or OSINT, encompasses everything that is publicly available on the internet and does not require payment or special technical efforts to obtain.

The OSINT process involves searching, collecting, and analyzing information from publicly accessible sources. This intelligence discipline finds applications in various fields, including business, politics, investigations, law enforcement, investing, and security.

Since the early 2000s, with the rise in popularity of social media and the Internet of Things, the volume of available information has grown rapidly. In recent years (2016-2019), OSINT has been actively integrated into business practices, political campaigns, investigative work, research, investments, and security operations.

According to CIA analyst Sherman Kent, policymakers obtain up to 80% of the information they need for decision-making from open sources. Even in the realm of intelligence activities, as General Lieutenant Samuel Wilson stated, over 90% of intelligence comes from open sources, with only 10% requiring operational measures and covert work.

Our advanced algorithms enable us to daily

detect extensive volumes of leaks, databases, and other critical information on the Internet and the Darknet. Currently, we are adding 1 to 2 terabytes of information to our database each day.


SEARCHING

We have devised a unique algorithm that allows us to search our database at speeds of up to 26 gigabytes per second. Currently, we are planning to expand our technical infrastructure and implement artificial intelligence algorithms to further enhance data processing outcomes.

We are not only involved in developing Open Source Intelligence (OSINT) technologies but also concurrently engage in creating our own solutions in the field of information security.



DATA ENCRYPTION

Cur company's specialists have developed a unique data encryption algorithm for any format. This algorithm allows our clients to store information on corporate servers, ensuring reliable protection against potential breaches or leaks. Unauthorized access attempts to confidential data are effectively prevented by the algorithm from being utilized for malicious purposes. Detailed information about our algorithm is available in a separate company presentation.



INFORMATION MARKING

Our proprietary technology for marking confidential data enables the integration of a special digital beacon into information of any format. This beacon is integrated with our reconnaissance system. If marked information becomes publicly accessible, we promptly recognize this fact and notify the owner, ensuring a swift response to potential threats.

DATA STORAGE

We have developed an algorithm that divides information into numerous parts, encrypts each part with a distinct code, and distributes them across hundreds of storage locations in the network. Data collection and decryption are only possible for the owner, ensuring the highest level of storage security. IFU.APP

This is our primary and flagship product, allowing clients from anywhere in the world to utilize our Open Source Intelligence (OSINT) services through a browser and an internet connection.

To initiate a search, simply enter the email address of interest and receive a detailed report after a short period.

The product interface is designed to cater to the needs of even novice users and does not require specialized knowledge.



N2Q.NET

This product is a data encryption tool built on the foundation of our company's unique algorithm.

This product operates in a closed mode and access is granted only to a select group of clients.

FALCON TERMINAL

This specialized product is developed for conducting in-depth investigations on the internet. It enables searches in both our company's database and external sources. The product also includes built-in algorithms for intelligent search, designed to assist investigators.



Cost Structure Formation

One of the key competitive advantages of our company and the offered products and technologies is our flexibility and adaptability. We are not constrained by templates of ready-made products; instead, we provide solutions that can be easily customized to the unique needs of each client. This allows clients to pay only for the functions and features they truly require, minimizing costs for unnecessary components.

This approach also enables us to reduce the cost structure of the provided services and offer competitive prices compared to alternative companies.

Furthermore, it's important to note that all the services we offer are digital and do not require physical production, storage, or logistical expenses.

Market Niche of the Company — Pricing Strategy

Based on our flexible cost calculation system, we also offer a flexible price list, allowing each type of customer to receive an individual pricing formula for our services.

When determining the price for each contract, our goal is for the service cost to constitute 30% of the total price, while the remaining 70% represents the company's revenue.

For example, when working with corporate clients, we offer a payment scheme based on the number of employees being protected. We provide several service packages with prices ranging from \$20 to \$50 per month per employee, depending on the level of protection.

Let's consider a scenario where there are 1,000 employees in a company, and the client selects the average level of protection at a cost of \$20 per month per employee. If security needs to be monitored for 300 employees, the monthly contract cost would amount to \$6,000, and for a year -\$72,000.

Taking into account the service cost calculation formula and tax payments, it is expected that the company's revenue from a single corporate client would be approximately \$50,000. This approach allows us to provide pricing flexibility and cater to the needs of each client while ensuring a sustainable income for the company.






Market Niche of the Company — **Potential Profitability**

Together with our partners, we embark on developing new technologies tailored to the specific region and promoting them. All technologies and products developed within this joint venture are subsequently introduced to global markets exclusively under its brand, with a mandatory indication of our company's technology usage.

Based on the joint company, we will create:







- The open source intelligence (OSINT) market is still in its early stages, which means there's a shortage not only of quality technologies but also of specialists who can work with them.
- In the near future, there will be a high demand in the global market for analysts, programmers, investigators, and technical consultants with professional skills in OSINT.
- Current cybersecurity experts often think too narrowly and sometimeslack even basic knowledge in internet intelligence.

- We understand that our company might also face a shortage of skilled professionals in the near future.
- To address this issue, we have developed a seven-stage training program for preparing specialists in the field of OSINT. The program includes over 150 hours of lessons and 30 practical seminars.
- Upon completing the course, all students receive a diploma, and the top graduates are guaranteed employment in our company or one of our partner companies.

You may have noticed that each step has its own basic cost. We do this because the final expense is determined by the partner who wants to work with us using this model.

What do we need from you?

- Organize ads for the course.
- Make groups for students and collect payments from them.
